AIR SOURCE HEAT PUMP TYPES

For Electrically heated homes only:

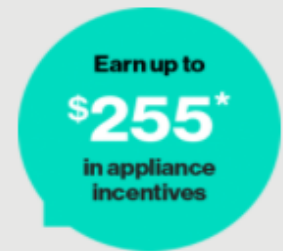
- **Upgrade from an Electric Furnace/baseboard OR replace existing ASHP**
- **Must Be:**
 - Used as primary heating Source
 - ENERGY STAR certified, and
 - Minimum efficiency rating of EER 12.5/SEER 15/HSPF 8.5
 - **For Cold Climate DUCTED ASHP must also** be (COP) at -15° C (5° F) greater than 2.0 at maximum capacity operation.

Ductless ASHP – Single Head, Electric Baseboard, No A/C or with A/C	\$1000
Ductless ASHP - Multiple Head, Electric Baseboard, No A/C or with A/C	\$1,000 per exterior unit and the first one interior unit. +\$250 for each one additional interior unit attached to the same exterior unit up to a maximum of \$3,000
Ductless ASHP - Cold Climate	\$1,500 for one exterior unit and the first interior unit + \$400 for each one additional interior unit attached to the same exterior unit up to a maximum of \$4,000.
Ducted ASHP Central Furnace, No A/C or with A/C	\$1250
Ducted ASHP -Cold Climate, Central Furnace, No A/C or with A/C	\$4000

- \$75 for installing an ENERGY STAR® Refrigerator
- \$75 for installing an ENERGY STAR® Freezer
- \$30 for installing an ENERGY STAR® Dehumidifier
- \$75 for installing an ENERGY STAR® Clothes Washer
